Glenn Hedman gave an update on the CPT codes. A new CPT code, 97755 for assistive technology evaluation is now available in the 2004 AMA's CPT Coding book. Two activities that we wish to advance over the next year include the development of educational materials regarding the codes, how to use, sample billing forms, the development of a system to establish a history of successful billing, among other issues.

Additionally, we plan to continue the investigation of the procedure to become a CMS recognized health care provider which is necessary to bill Medicare for services.
